## Company Background

SAAM Energy Development Public Company Limited was established on 7 September 2007 to engage in the procurement of project site location and rendering of related services within solar power projects for clients who operate the project and sell the electricity generated from such operations. The Company foresaw business opportunities and started developing solar power projects with its client group, whereby SAAM Group procures the right to use land in the form of lease or purchase to serve as the clients' project site location, as well as provides related services for the duration of the agreement throughout 20 or 25 years. SAAM Group currently provides such services for 17 projects with combined capacity of approximately 41.1 MW on over 750 rais of land.

Later, the Company expanded its revenue base to renewable energy project investment, as operator of a solar power project under its subsidiary. SAAM Group executed 2 Power Purchase Agreements with the Provincial Electricity Authority, with installed capacity of 2 MW per project under the Feed-in-Tariff scheme for a duration of 25 years, 1 of which has already commenced commercial operations.

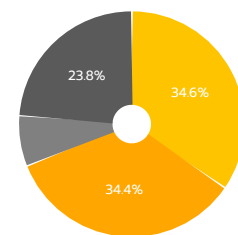

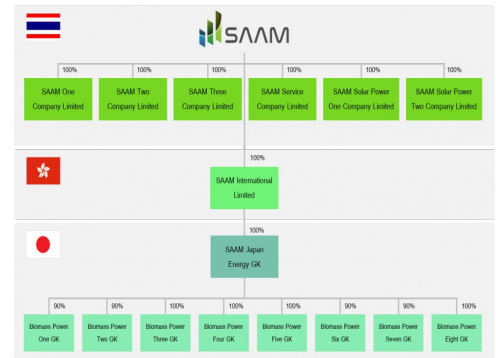

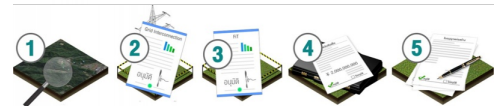

# Business Plan

At present and in the next 2 years, SAAM Group aims to operate its business in renewable energy project development for sale, with plans to expand its business in developing various types of renewable energy projects in potential geographies including Japan and other countries in Asia, to generate cash flow streams for use as capital in investing in renewable energy projects which SAAM Group has developed. In the long-term, SAAM Group will engage in renewable energy project development for sale domestically and internationally, as well as the procurement of project location and rendering of related services for constant returns. In addition, SAAM Group places emphasis on investment in businesses related to renewable energy project operations to strengthen the value chain for stakeholders of the renewable energy project in the future.

## Investment Highlight

**The Company has the following key business goals:**

- 1) To develop renewable energy projects for sale in the form of solar power projects, biomass power projects, geothermal power projects, hydropower projects, and wind power projects domestically and internationally, with the goal to develop a total of 100 MW of renewable energy projects for sale by 2020
- 2) To invest in other companies which operate the business related to renewable energy projects by 2020
- 3) To invest in renewable energy projects which the Company has developed by 2020

## Risk Factor

**Key operating risk factors are as follows:**

- Risk of dependence on major clients
- Risk of dependence on a few clients
- Risk of early termination of long-term lease agreement by land owners and being unable to renew lease agreement after expiry
- Risk of electricity generation being less than expected
- Risk of natural disasters or force majeure
- Risk of changes in policy by the government or other related government agencies
- Risk of not being fully in compliance with laws and regulations related to the business
- Risk from competitive situation in the renewable energy project development for sale business
- Risk of uncertainty in successful development of renewable energy project for sale overseas and the returns from project development not being as expected
- Risk of delivery of work to clients in the development of renewable energy project for sale overseas digressing from target
- Risk of discontinuity of revenues from renewable energy project development for sale business
- Risk of high bargaining power of clients in the renewable energy project development for sale business
- Risk of sourcing funds for use as capital in the development of renewable energy project for sale
- Risk of procurement of land for renewable energy project development in the future
- Risk of dependence on key executives
- Risk of dependence on specialized personnel
- Risk of control by major shareholders in shareholders' meetings
- Risk arising from litigation which could affect the value of assets reflected in the consolidated financial statements for SAAM-SP2 project
